#### A. Northeast Michigan Regional Council on Aging – Scott Ulery

#### B. Michigan Senior Advocates Council (MASC) – Lorelei King

King handed out a packet called Communication Best Practices. Discussed agism and flip the script. Do not use the word senior to talk about older adults. When using senior is denotes frail, old age, lost their usefulness. Instead define what age group you are talking about, for example older adults aged 60-70.

MASC, May 28<sup>th</sup> meeting, senate passed an 84.5 billion dollar budget with major investments in healthcare, infrastructure, and older adult services. However, shortly after that was passed, the house issued resolution 113 that accused the senate of violating the constitution. Claiming that the house appropriations funds were in excess of available revenue. So now it is going back to the drawing board again.
