Region 9 Area Agency on Aging Annual Report:

Laurie Sauer, Director, gave an overview of the AAA FY 2017 Annual Report, Region 9 Quick Facts, and estimate funding formulas.

Sauer stated that funding is based on an interstate funding formula. Region 9 only gets 3.34% of the state funding. Decreases have been because of a decrease in population and not because of state funding.

C. <u>Competitive Wage Challenges:</u>

Director Snyder discussed the competitive wage issues. Governor Snyder has signed into law, an increase to \$12.05 by 2030. January 1, 2019 will be an increase from \$9.25 to \$9.45. Right now the question is about leave and when it will be available. The county in looking into the issue. Director Snyder, Woods and Dedenbach, will make a work group to come back with recommendations at the March meeting.
